THIS MEMORANDUM OF UNDERSTANDING is made on day of 2017.

Between

Islamic Relief Malaysia (Registration No : 657354-W) a non-governmental organization (hereinafter referred to as 'IRM') and having its registered address at A-05-1, Paragon Point, Jalan Medan PB 5, Seksyen 9, Pusat Bandar, 43650 Bandar Baru Bangi, Selangor Darul Ehsan, of the other part.

And

..... (**Business Reg. No.**) is a company (Referred to as "IRM Humanitarian Partner") having its address at, of the one part and shall include its lawful representatives and permitted assigns of the one part.

IRM and **IRM Humanitarian Partner** shall hereinafter referred to singularly as "Party" and jointly as "the Parties".

WHEREAS;

1. IRM Humanitarian Partner is an entity that runs a business of
2. IRM Humanitarian Partner complies with the local laws and regulations for the time being in force in all dealings with the local authorities.
3. IRM Humanitarian Partner complies with the Malaysian laws and governance for Anti-Money Laundering, Anti-Terrorism Funding and Proceeds of Unlawful Activities Act 2001.



4. IRM hereby appoints and engages IRM Humanitarian Partner as IRM Third Party Fundraiser; and IRM Humanitarian Partner hereby agrees to accept the appointment.
5. IRM and IRM Humanitarian Partner shall identify areas of possible interest and collaboration, with a focus on implement social and welfare developments programmes in Malaysia and abroad.
6. IRM hereby agrees to allow IRM Humanitarian Partner to use the name and logo of IRM to reflect IRM Humanitarian Partner's affiliation with IRM for IRM Humanitarian Partner's social responsibility ("SR") programmes.
7. To convene minimum of twice yearly to discuss on related issues pertaining to the implementation of this MOU. The arrangement with regard to the venue and time shall be determined through mutual consultations and/or negotiations between both parties.
8. IRM Humanitarian Partner agrees to contribute **RM/percentage of** to IRM as part of it support towards humanitarian causes.
9. IRM Humanitarian Partner agrees to transfer the contribution towards IRM's bank account on **[monthly, quarterly, bi-annually, or annually]** basis.
10. IRM will issue a receipt for every contribution transferred to IRM's bank account. All monetary contribution to IRM are tax-exempted under sub-section 44 (6) of income tax 1967. Ref. No: LHDN.01/35/42/51/179-6.6249.
11. This Memorandum of Understanding will remain in force for a period of **TWO (2) years** with effect from the date of signing of this Memorandum of Understanding.
12. Following a review by both parties at the end of the year, this MOU may be extended for a further agreed period.
13. Either Party hereto shall be entitled to terminate this Memorandum of Understanding at any time by giving the other Party in writing not less than ONE (1) month prior termination. Termination shall be without penalty.



14. All materials, outputs or publications produced pursuant to any project falling under this Memorandum will clearly acknowledge the support of both parties.

15. The Parties agree to allow each other to publicize each other's respective logos on all such marketing material with the parties' mutual consent.

16. Any publicity or media events relating to common projects shall be conducted where jointly planned and coordinated by the Parties and with the Parties' mutual consent.

17. Neither party shall claim any intellectual property rights in the logos and designs provided by the other party.

18. Nothing in this article shall affect the rights and interests of the Parties in respect of any intellectual property in any logos, materials or publications provided by one Party to the other Party.

19. This Memorandum may be amended or varies from time to time by mutual agreement, provided that any amendment is in writing and signed by both Parties. The term of the memorandum may be extended by mutual written agreement.

20. Any different or dispute between the Parties concerning the interpretation and/or application of any of the provision of this Memorandum of Understanding shall be settled amicably through mutual consultation and/or negotiations between the Parties without reference to any third party.

21. IRM agrees to provide bunting for IRM Humanitarian Partner to promote on this collaboration.

22. Other printed promotional materials shall be borne by IRM Humanitarian Partner with prior approval or advice by both parties.
